A land development permit is required for all NON-CONSTRUCTION land development activity except cleaning of undergrowth and trees under 8" caliper diameter.

Standards for all Land Development

- 1. Land development permits for less than 5 acres require a Small Construction Notice of Intent (SCNOI) and storm water pollution prevention plan (SWPPP) with application
- 2. MDEQ certificate required with application for land development for 5 acres or more along with documentation of the Large Construction Notice of Intent (LCNOI) filed with the Mississippi Department of Environmental Quality (MDEQ)
- 3. ROW and other easements must be protected by the applicant. Responsibility for any damage is with the applicant and must be returned to predevelopment state prior to CO being issued.
- 4. SPECIAL FLOOD HAZARD AREA REQUIREMENTS Section 11-23(8) a.of the City of Tupelo Flood Damage Prevention Ordinance states: "Floodways: Prohibit encroachments, including fill, new construction, substantial improvements, and other developments unless certification (with supporting technical data) by a registered professional engineer is provided demonstrating that encroachments shall not result in any increase in flood levels during occurrence of the base flood discharge; ..." All flood zone activity must be verified by staff prior to issuing permit to ensure compliance.
- 5. Tree Protection and Mitigation Checklist and attachments, see separate form, is required for all land development permits
- 6. The applicant is responsible for fulfilling any State or Federal regulations in addition to these standards.

Note: The applicant is responsible for obtaining all State and Federal permits required for their activity and is the sole party responsible for State and Federal regulation violations.

^{**}Burning: Prescribed burning will be allowed in Agriculture/Open Space zoning districts only with a minimum 60 contiguous acres, and can only include material harvested from the site. No prescribed burns will be allowed until the owner has obtained the applicable MS Forestry Commission permit(s) and submitted copies to the City of Tupelo.
